



## **Privacy policy PROVADA**

For the use of our services and via this website, privacy-sensitive data is being processed. PROVADA considers careful handling of personal data of great importance. Personal data is therefore carefully processed and secured by us.

In our processing we adhere to the requirements of privacy legislation. This means, among other things, that:

• we **clearly state the purposes** for which we process personal data. We do this through this privacy policy;

• we **limit our collection of personal data** to only the personal data that is necessary for legitimate purposes;

• we **first ask you for explicit permission** to process your personal data in cases where your permission is required;

• we **take appropriate security measures** to protect your personal data and that also require this from parties that process personal data on our behalf;

• we respect your right to provide your personal data for inspection, correction or termination at your request.

We as PROVADA are responsible for the data processing. In this privacy policy we explain which personal data we collect and use and for what purpose. We recommend that you read it carefully.

# **USE OF PERSONAL DATA**

When using our services and website, we obtain certain information from you. That could be personal data. We only store and use the personal data that is directly provided by you, in the context of the service you have requested, or of which it is clear that they are provided to us for processing. We use your data, for example, when you visit our website, create an account, use our services or contact us.

We use the following data for the purpose stated in this privacy policy:

- Name
- Address
- Phone number
- Sex
- Photo
- Billing information
- Email
- Payment data
- Profile data

It is possible to specify certain preferences and interests (profile data) via registration forms, depending on the event for which you are registering. Think of interests in certain products or services.

Furthermore, your IP address, type of browser, operating system, language settings and pages (on the website) that are shown to you are collected. This information is only used to make navigation easier and to improve the website. For information about the use of cookies on our website, please refer to our cookie statement. # **REGISTER / SIGN IN**

It is possible to create an account or log in for certain parts of our services. We keep any information that you provide to us, so that you do not have to enter it every time. We do this so that we can contact you in the context of the implementation of the agreement. We keep your data as long as you use our services. We process your data in order to be able to register you for a visit to the fair and to send you information about the content and activities that are part of it.

We will not provide your information to third parties, unless this is necessary in the context of the execution of the agreement you conclude with us or if this is required by law. In case of suspicion of fraud or abuse of our services, we can hand over personal data to the competent authorities.

## **DELETE ACCOUNT**

You can cancel your account and / or have your data deleted, by sending us a request by email. We will process your request as soon as possible. We will delete your account and / or data as soon as possible, but no later than within one month. We may need to keep certain information longer, such as (if applicable) payment information. This applies to the tax authorities, for example, a statutory retention obligation of seven years.

# CONTACT FORM AND NEWSLETTER

Via our website we offer the possibility to ask questions through a contact form, where you are asked to fill in various information to deal with your question. You choose which information you provide. The data that you send us will be kept for as long as the nature of the form or the content of your email is necessary for the complete answering and processing. We offer a newsletter with which we want to inform interested parties about our products and / or services. Every newsletter contains a link with which you can unsubscribe.

## SCANS

It is possible that your access badge is scanned within certain parts of our services. The data that becomes available as a result will be used to keep you informed of the service and to improve the quality of the service. If you have been scanned, for example during a meeting, and you want to have your data deleted, you can send a request to this effect by email (see contact details at the bottom of this document). We will delete your data as soon as possible, but no later than within one month.

### **ADVERTISEMENTS**

Our website may display advertisements from third parties that keep personal data in order to tailor it.

### **DISCLOSURE TO THIRD PARTIES**

We can pass on your data to our partners. These partners are involved in the implementation of the agreement. Social media buttons are included on our website. The administrators of these services use this to collect your personal data.

### SECURITY

We take security measures to limit misuse of and unauthorized access to personal data. In particular, we take the following measures:

- access to personal data in your account is protected with a username and password;
- the data is stored in a separate, protected system upon receipt;
- we take physical measures to protect access to the systems in which personal data are stored;
- we use secure connections (Transport Layer Security / Secure Sockets Layer, abbreviated TLS / SSL) with

which all information between you and our website is protected when you enter personal data;





# **RETENTION PERIODS**

The personal data described above is stored for a period of 3 years. The data are then deleted, unless there is a legal obligation that requires longer storage (such as the tax seven-year retention period for payment data).

## **CHANGES IN THIS PRIVACY POLICY**

We reserve the right to make changes to this privacy policy. We recommend that you consult this policy on a regular basis, so that you are aware of these changes.

## ACCESS, CORRECTION AND TERMINATION OF YOUR DATA

For questions about our privacy policy or questions about access to, changes or removal of your personal data you can contact us via the contact details at the bottom of this page. You can send us a request to view, change or delete your personal data. You can also submit a request to view the data that we store with your permission, that is processed in the context of an agreement with us or state with reasons that you want us to restrict the processing of personal data.

We will respond substantively to such a request as soon as possible and within one month at the latest. In case of a difficult request, we will notify you within one month and will respond no later than two months thereafter.

To prevent abuse, we may ask you to identify yourself adequately. When it comes to access to personal data linked to a cookie, you must send a copy of the cookie in question. You can find this in the settings of your browser. If the data is incorrect, you can request us to change the data or have it removed.

## **AUTHORITY PERSONAL DATA**

Of course we are happy to help you if you have complaints about the processing of your personal data. ### **COOKIE STATEMENT PROVADA**

This website uses cookies. Cookies are also placed via third parties engaged by us. A cookie is a simple small file containing pages of this website, sent along and stored by your browser on your computer's hard drive.
